Notice is hereby given that sealed proposals will be received in the office of the City Clerk of the City of South Milwaukee at the Administration Building, 2424 15<sup>th</sup> Avenue, South Milwaukee, WI 53172 **until 11:00 a.m. on Tuesday February 16, 2021** at which time they will be publicly opened and read for the above public works improvement contract which will include Carrington Avenue & Kirkwood Avenue Water Main Replacement and Asphalt Pavement Rehabilitation.

- 12" PVC Water Main 850 L.F.
- 6" PVC Water Main 130 L.F.
- 12" Gate Valve 2 EA
- 6" Gate Valve 3 EA
- Hydrant Assembly 1 EA
- Reconnect Water Service Laterals 8 EA
- Concrete Pavement & Alley Replacement 140 S.Y.
- Curb Removal & Replacement 225 L.F.
- Asphalt Milling (Full Depth) 2600 S.Y.
- Asphalt Base 450 TONS
- Asphalt Surface 265 TONS
- Quantities of traffic control, CAB, pavement sawcutting, lawn restoration, and other items applicable to the above work.

The document set describes items and final quantities for bid proposal. It is anticipated that a contract will be awarded by the South Milwaukee Common on February 17, 2021 and the work shall be substantially complete by June 30, 2021, unless otherwise allowed by the Engineer.

Document sets for bidding must be obtained from Quest. There is a non-refundable fee of forty (\$40) dollars per set.

Prequalification forms for 2021 are required to be on file in the Office of the City Engineer for all contractors and subcontractors at least seven (7) days prior to bid opening. Forms are available from the Engineer's Office upon request or on the City's website: <https://wi-southmilwaukee.civicplus.com/DocumentCenter/View/239/Prequalification-Application-PDF>. The Common Council's decision as to qualification shall be final.

Proposal must be placed in a sealed opaque envelope addressed to: **"City Clerk, City of South Milwaukee, Wisconsin"** and marked **"Proposal for Carrington Avenue & Kirkwood Avenue Water Main Replacement and Asphalt Rehabilitation"**. If the bid is sent by mail, the sealed envelope shall be enclosed in a separate mailing envelope with the notation **"Sealed Bid Enclosed"** on the face thereof.

The City of South Milwaukee reserves the right to reject any or all bids and waive any informalities in the bidding. No bids shall be withdrawn after the opening of the bids without the consent of the City of South Milwaukee, Wisconsin, for a period of thirty (30) days after the scheduled time for closing bids.

All proposals must be submitted on a form provided for that purpose as issued within the Document Set, together with a certified check or a bid bond not less than five (5%) percent of the bid, payable to the City of South Milwaukee as a guarantee that, if the bid accepted, the bidder will execute and file the contract and a performance bond in the amount of one hundred (100%) percent of the total proposal price within ten (10) working days after the award of the contract. Failure to execute such contract and performance bond shall be cause for forfeiture of the check or bid bond as liquidated damages.
